Design Review Board Update

Happy Holidays! The CVC DRB is pretty quiet during the holiday season, with most inquiries focusing on holiday decorations. The Design Guidelines regulate holiday lighting, with seasonal display of decorative holiday lighting allowed between November 15 and January 15, and small white lights in a reasonable amount of trees allowed between November 15 and March 15. Other than during the holiday season, the Design Guidelines require exterior lighting to be dark-sky friendly certified fixtures. Generally, a dark sky fixture is one where the light source is not visible, is shielded from view such that no light emanates toward the sky or outward to the sides, and light only emanates below the light source. Additionally, the maximum output of any one fixture is limited to 400 lumens. Please reach out to CVC DRB Administration if you are interested in replacing your exterior light fixtures. Darksky.org is a great resource for additional information.


As there is limited land remaining for new homes, the demand from owners has shifted to reviews of additions, remodels, and landscape improvements. CVC has only 4 vacant lots remaining, all of which are now owned by the adjacent homeowner. In addition to the Clubhouse remodel and the 9 Club Residence homes, there are just 3 homes currently under construction. The DRB works closely with Public Safety to enforce the Construction Rules and Regulations.

CVC DRB Administration is able to quickly approve most smaller projects, including applications to change the color of one's home, replacement of windows, landscape and yard modifications, deck or patio additions, re-roofs, and building additions. All of our application forms are available on-line at mpgvail.com/design-review-administration/cordillera-valley-club-drb/ and we can process most requests via email.









Cordillera Valley Club - Fishing Program

Did you know

Cordillera Valley Club participates in the Cordillera fishing program! Cordillera offers fly fishing access to six well stocked ponds and 1.3 miles of wild trout in the Eagle River. The ponds are located on Bearden Rd, Red Draw, Granada Glen, Granite Springs Rd, and Valley Course hole #3. Cordillera's Eagle River fishing rights are located downstream of Hillcrest Drive near the West entrance to the Cordillera Valley Club. Vail Valley Anglers manages the fly fishing program providing expert guides and gear at reserved rates for Cordillera's fishing members. VVA is located in the Riverwalk Center at Edwards. Call (970) 926-0900 for tips, trips, and reservations. The Cordillera River Parcel is near the West gate of CVC. CVC property owners can fish with VVA guide or fish unguided after completing the one time orientation of the property, rules & regulations, and member benefits.

Rules and Regulations of the Fishing Program:

- All fishing is catch & release with flies and single barbless hooks.
- No baits, scents, or chumming while fishing ponds & Eagle River.
- Ponds are open without reservations during daylight hours as long as no ice is present on the surface.
- Please respect neighboring properties by keeping noise to a minimum when fishing the ponds.
- State of Colorado Fishing License required for fishing the Eagle River.
- Fishing access may be limited to protect the fisheries for environmental and public safety concerns.
- Reservations are required for "guided" and "unguided" trips on the river parcel.
- One time orientations of the R&Rs, property, and member benefits must be completed prior to unguided river trips.
- No more than two anglers per boat reservation (one must be a current Cordillera Fishing Permit holder).
- VVA is the only guide service permitted to operate on Cordillera's River Parcel and Ponds.

Reservations

Authorized anglers are required to book reservations in advance with VVA. Please call (970) 926-0900, stop by the fly shop, or book online at

http://www.vailvalleyanglers.com/member-cordillera-booking-page.

The username is cordillerafishing and the password is vva2023#.

Reservations can be made up to 10 days in advance.
